

## 23RD ANNUAL 800 CLUB TOURNAMENT BOWLERO WEST END 8037 SHRADER ROAD

This tournament is open to all youth and adult members of the Greater Richmond USBC and the Appomattox River USBC who have bowled a three-game series of 800 or better within these two jurisdictions. Any member of these associations who has bowled an 800 series outside of these guidelines must have been a member of one of these two associations in the 2022-23 season with a GRUSBC or ARUSBC yearbook average for at least 21 games. (Need to provide proof of eligibility)

## ALL BOWLERS MUST BE USBC CERTIFIED FOR 2023-2024 SEASON

This scratch tournament will be conducted as a singles tournament on a sport condition with a stepladder roll off. Each bowler will bowl a three-game series on multiple pairs of lanes with the top five bowlers qualifying for the roll off. In case of a tie for roll off position, there will be a 9<sup>th</sup> & 10<sup>th</sup> frame roll off to determine the place the bowler takes in the stepladder finals. The winner of the tournament will receive a nice trophy. Any prizes won by youth bowlers will be submitted to SMART.

There will be a voluntary jackpot, brackets, and side pots that you may enter.

Prize monies will be returned 100%. This is a USBC Certified Tournament and all entrants must be able to show a USBC membership card or pay \$25.00 per rule 300c1.

The top five (5) places will be paid and the amount will be determined based on the number of entries.
